Notice Concerning the Decision on the Details of the Issuance of Stock Compensation-type Stock Options (Stock Acquisition Rights)

Tokyo (May 12, 2017) - Bridgestone Corporation (the "Company") has announced that regarding the issuance of stock compensation-type stock options (stock acquisition rights) resolved on at a meeting of its Board of Directors held on April 27, 2017, the details of the issuance of these stock acquisition rights has been decided upon today, as described below.

1. Name of the stock acquisition rights

Bridgestone Corporation's 15th Stock Acquisition Rights Plan A (Stock Compensation-type Stock Options)

2. Amount to be paid in exchange for the stock acquisition rights

¥357,700 per stock acquisition right (¥3,577 per share of common stock)

Note: The above amounts are calculated using the Black-Scholes model, based on the closing price of the Company's common stock on the Tokyo Stock Exchange on the allotment date. The payment obligation for the amount to be paid in exchange for the stock acquisition right will be offset by the Company's obligation to pay the equivalent amount of the compensation to the grantee.
